1. CEOs Advisory Council Meeting:

The CEOs Advisory Council held its third meeting for the year 2015 and discussed the latest developments in the banking sector as well as UBF activities primarily Trust Index, Financial Literacy, Code of Conduct and the Annual Conference.

UBF Compliance Committee started working on a special survey report on subject to explore banks positions and conclude recommendations.

6. <u>AI Etihad Credit Bureau</u> (AECB):

Meetings with AECB continued to discuss the launch of commercial credit reports as well as consumers scoring phase.



7. Higher Shariaa Authority:

UBF Sub-Committee continued its meetings with the concerned committee of the Central Bank and has concluded the first draft of the charter proposed by the Central Bank.
